Through six issues, the City contends that 1) the trial court erred in sustaining Jackson's motion to quash the arrest because the City failed to prove that it received a police report concerning Jackson's alleged misconduct and information concerning his residency at the time of his arrest, 2) the trial court erred by failing to compel arbitration, 3) the trial court erred in considering an affidavit from an out-of-state witness that was not competent evidence, 4) the arrest warrant was invalid because it did not satisfy the requirement of strict statutory compliance by containing the wrong address, 5) the trial court erred in quashing the arrest warrant because the affidavit supporting it failed to establish probable cause, and 6) the trial court erred in quashing the arrest warrant because it was void for lack of specificity. We affirm the judgment of the trial court. Background Jackson was charged with the offense of assault on a public servant arising from an altercation he had with a deputy constable. He was arraigned and later pleaded not guilty. On March 23, 2006, a trial on the merits was held, and the jury found him guilty of the offense. On July 3, 2006, the trial court sentenced him to
